The State level V&MC is the highest body in respect of evaluating performance of the function of V & MC at District/ Constituency, Block & Sub-Divisional level constituted in the State for ensuring transparency of the Public Distribution System as well as to ensure Accountability of the Authorities at different levels.

The State Level Vigilance & Monitoring Committee on PDS will examine and review the functioning of the following Vigilance & Monitoring Committee on PDS in the State, on a periodic basis, say twice in a year [in Aug and Feb]:-

- i. District Level
- ii. Block Level
- iii. Constituency Level
- iv. Sub-Division Level
- v. Ward Level
- vi. F.P. Shop Level.

The State Level Committee will issue specific direction in respect of Lifting/ Storage/ Distribution of PDS items on the basis of its review District/ Sub-Division/ Constituency/ Municipality wise, to be enforced by the concerned Authority of Govt. of Assam, (FCS&CA Deptt.), IOCL.

The State Level Committee may also refer / forward suitable case of complaint/grievance to the State Consumer Redressal Forum or and the District Consumer Forum to ensure that the targeted people (as per various Govt. Schemes) are not deprived of the benefits, the Govt. wants to deliver to them.

In the interest of the people, at large of the State, the State Level Committee is free to suggest measure it thinks suitable /appropriate for the State of Assam so as to enable the Govt. of Assam to move Govt. of India to modify the existing policy/ Programme/System.
