GOVERNMENT OF ASSAM ORDERS BY THE GOVERNOR FOOD, CIVIL SUPPLIES AND CONSUMER AFFAIRS DEPARTMENT

NOTIFICATION

The 14th December, 2022

No. FSA.109/2.- The following draft rules further to amend the Assam Food Security Rules, 2022 herein after referred to as the principal Rules which the Governor of Assam proposes to make in exercise of the power conferred by section 40 of the National Food Security Act, 2013 (Central Act No. 20 of 2013) is hereby published as required under sub-section (1) of section 40 of the said Act for information of all persons likely to be affected thereby and notice is hereby given that the said draft amendment rules shall be taken into consideration after the expiry of a period of 10 days from the date of publication of this notification in the Official Gazette.

Any objections or suggestions which may be received from any individual in respect of the said draft rules before the expiry of the period specified above shall be considered by the Government of Assam.

Objections or suggestions, if any, may be sent to the Additional Chief Secretary to the Government of Assam, Food, Civil Supplies and Consumer Affairs Department, Janata Bhawan, Dispur, Guwahati – 781006.

- Short title and commencement
- 1. (1) These rules may be called the Assam Food Security (Amendment) Rules, 2022.
 - (2) They shall come into force on the date of their publication in the Official Gazette.

Amendment of rule 3

2. In the principal Rules, in rule 3, in sub-rule (4), in clause (xiv), in second line, for the words and figure "Rs. 1 lakh" appearing in between the words "less than" and "per annum" the words and figure "Rs. 2,50,000.00 (two lakhs fifty thousand)" shall be inserted.

Amendment of rule 5

- 3. In the principal Rules, in rule 5, after sub-rule (7), the following sub-rule (8) shall be inserted, namely:-
 - "(8) The Deputy Commissioners of the concerned district shall approve the final list of the beneficiaries with the approval of the Guardian Minister of the said district.

In respect of Sixth Schedule areas the final list of beneficiaries shall be finalized by the Principal Secretary of the Council with the approval of the Chief Executive Member of the Council and the Guardian Minister of the District".
